Council Discussion Items:

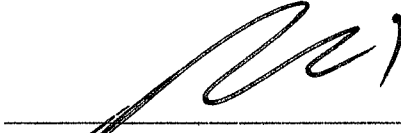
- Create waste ordinance and discuss with attorney for review. Will try to have available for July 23rd council meeting.

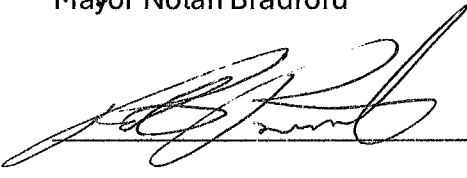
