REGULAR COUNCIL MEETING
11/13/2025

The City Council of Hanceville, Alabama, met in public session on November 13, 2025, immediately following the work session at 6:00 PM in the Council Chambers of City Hall.

Mayor Paul Campbell called the meeting to order, led the prayer and followed with the Pledge of Allegiance.

Mayor Campbell opened the floor for public comments.

Ms. Katie Whitley addressed the city council asking them to consider putting a light on each side of the civic center and stating that you couldn't tell where the pavement ends and the sidewalk begins.

The Civitan Club, represented by Tonya Godbee, requested sponsorship from the city in the amount of \$250 for the Annual Christmas Parade.

Councilor Bradford requested that the Public Works Bi-Weekly Job Detail include the dates that things are done and start and end dates for projects, recurring for daily activity.

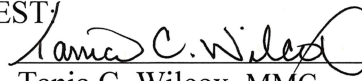
