Non-resident students whose resident school district is in Genesee County, or a contiguous county (Lapeer, Livingston, Oakland, Saginaw, Shiawassee or Tuscola) may apply for acceptance to Lake Fenton Community Schools by submitting this application between March 3, 2026 and August 7, 2026.

Lake Fenton Schools will make every effort to process your application as quickly as possible, but acceptance is dependent upon the availability of administrators from all school districts from the last two years being contacted. After June 5th, this application may not be approved until after August 1, 2026 due to the availability of district administrators in all school districts. If you have not received a letter of acceptance or denial by August 7, 2026, please contact the Superintendent's office at 810.591.2532.

If the application is approved, the student must be enrolled by 4:00 p.m. on Friday, August 28, 2026.
